## 1. What information does Young Chef of the Year Pty Ltd collect?

Each time someone visits our site, our web server collects the following types of information:

- The number of users who visit
- The date and time of visits
- The number of pages viewed
- How users navigate through the site

Young Chef of the Year Pty Ltd collects two types of information:

- Optional and voluntary submissions. These are voluntary submissions to submit an application form, email a friend and participate in competitions;

Young Chef of the Year Pty Ltd gathers information through aggregated tracking derived mainly by tallying page views throughout our sites. This information allows us to better tailor our content to readers' needs and to help our advertisers and partners better understand the demographics of our audience. Because Young Chef of the Year Pty Ltd derives its revenue from sponsorships, providing such aggregated demographic data is essential to keeping our service free to users.

## 2. How does Young Chef of the Year Pty Ltd collect information?

### 2.1 Application Forms

To be considered for the Electrolux Young Chef 2010, Electrolux Young Waiter 2010 or Electrolux Young Restaurateur 2010 awards, applicants are required to submit an application form containing personal details and information.

### 2.2 Cookies

We use technology called cookies when you visit our site. Cookies are small pieces of information which can be stored on your hard drive (persistent cookies) or in memory (session cookies). They can record information about your visit to the site, allowing it to remember you next time you visit and provide a more meaningful experience.

We use cookies to offer you increased security. Despite common myths, the cookies we send to your PC cannot read your hard drive, obtain any information from your browser or command your computer to perform any action. They are designed so that they cannot be sent to another site or be retrieved by any site other than Young Chef of the Year Pty Ltd.

A user may refuse cookies by turning them off in their browser. If you've set your browser to warn you before accepting cookies, you will receive the warning message with each cookie. You do not need to have cookies turned on to use this site. However, you do need cookies to actively participate in polling.

All information, regardless of who provides it, will be handled by Young Chef of the Year Pty Ltd in accordance with this privacy policy.

### 3. Use of Information

The type of information we collect from you will depend on what online services you use.

We use any information voluntarily supplied by our users to improve the web site, whether to provide interactive or personalised elements on the site or to better prepare future content based on the interests of our users.

Tracking information is used to determine which areas of our site users like and dislike based on traffic to those areas, we do not track what individual users read, but rather how well each page performs overall.

We create reports on user demographics and traffic patterns for sponsors. This allows our partners to advertise more effectively. As we don't track the usage patterns of individual users a partner is unable to identify whether a user has clicked on their advertisement. We will not disclose any information about any individual user except to comply with applicable law or valid legal process or to protect the personal safety of our users or the public.

### 4. Sharing of Information

We use the above information to tailor our content to suit your needs and help our partners better understand our audience's demographics. This is essential to keep our service free.

We will only use or disclose personal information or information generated by cookies in accordance with the Young Chef of the Year Pty Ltd Privacy Policy.

### 5. Security

Young Chef of the Year Pty Ltd operates secure data networks protected by industry standard firewall and password protection systems. Our security and privacy policies are periodically reviewed and enhanced as necessary and only authorised individuals have access to the information provided by our customers.
